PROCEEDING OF THE SELECTION COMMITTEE MEETING

Selection of eligible Mission Shakti SHGs for Ward Office Management for the year 2023-24

Date: 27th February, 2023

Venue: Council Hall, Khordha Municipality

In pursuance to letter No.2245 dated 31st Jan. 2023 and Letter No 2268, dated 1st February 2023, of the H&UD Department, Government of Odisha, a Selection Committee was constituted at Khordha Municipality vide Notification No. 426 dated - 17.02.23 to select eligible Mission Shakti SHG for Ward Office Management.

As decided by the Chairman of the Selection Committee on dtd.17.02.23 all the Bid / EoI received in the O/O Khordha Municipality were opened in the presence of all members of the Selection Committee. It was observed that a total of 62 nos. of Bid / EoI were received which were scrutinized by the committee. It was also decided by the committee to invite all the applicants for Personal Interaction (PI) and verification of original documents in a phased manner. Accordingly, in the first phase i.e., on 22/02/23 total 34 nos. of applicants were invited for Personal Interaction (PI) and verification of original documents. Total 30 nos. of applicants turned up for the Personal Interaction (PI) among them. As per the decision of the Selection Committee, police verification report obtained from the local police-station and financial irregularities from the concerned Banks of the MSGs applied for the said reason. As per the police verification report submitted by the local police MSGs applied for the ward office management are not involved in any criminal activities and as reported by the Bank only one MSG namely Sai Shradha SHG of ward no. 9 has financial irregularities. Hence, as decided by the Committee Sai Shradha MSG was disqualified

for the said purpose. One MSG named as Sanatan MSG, Ward No.14 withdrawn and remained absent. Another MSG named as Narayani MSG, Ward No.16 could not appear for an inevitable reason and requested to reappear on a different date. Committee considered her case and allowed her for Personal Interaction (PI) along with the remaining applicants on 24/02/23.

As decided by the committee remaining 28 applicants were invited for Personal Interaction (PI) and verification of original documents on 24/02/23. Total 24 nos. of applicants turned up for the Personal Interaction (PI) on that day.

The Selection Committee adhered to the guidelines issued by the Additional Secretary to Govt. in H&UD Deptt. Vide letter No.2245 dtd. 31/01/2023 and verified the original documents of MSGs with the documents given by them in the Bid / Eol. After that, the President / Secretary of the MSG and proposed Ward Co-Ordinator were called for Personal Interaction. They were asked regarding Panchasutra, previous income generation activities of the group, qualification of the group members, whether availed loan from the Bank, repayment of the loan, etc. by the members of the Selection Committee.

It is observed that in four wards such as (W-6, W-20, W-21, W-22) only one MSG had applied. It was unanimously decided by the committee that in those wards where more than one MSGs have applied scoring process will be followed for the final selection of the MSG. Accordingly, the committee scored the MSGs applied in the rest 18 wards.
